

Consultation on Dorset Enhanced Partnership Plan and Scheme

The council has started the process of creating an Enhanced Partnership following the submission of the Bus Service Improvement Plan (BSIP) to the Department for Transport. This will be a legally binding agreement between the council and local bus operators and sets out how we will work more closely together to improve bus services across Dorset.

There are two parts of the Enhanced Partnership which we are now seeking the views on. These are:

The Enhanced Partnership Plan - sets out a summarised version of the BSIP, providing the background for the proposed local bus service improvements

The Enhanced Partnership Scheme - sets out an agreed set of actions to deliver the BSIP proposals

Read the full draft of the Enhanced Partnership Plan and Scheme.

The delivery of our BSIP proposals are subject to the funding being made available by the Department for Transport. As such the Scheme has been designed as a 'shell agreement' setting out the themes and how we intend to work together. The Scheme will be updated over time to include more detail as funding becomes available.

Following the consultation exercise, we intend to 'make' the Plan and the Scheme which will then take effect from 1 April 2022.
