- 1. It is stated that there are historic records of flooding in 2000. Are you able to confirm the type of flooding, was it residential, or an open space etc?
- I have spoken with Daniel Griffin about the site. I wasn't sure if the EA owned the unnamed tributary of the Shreen Water which he confirmed, the EA does not.

In our conversation he mentioned the presence of flood defences within the site area. From the document sent in the Product 4, titled Flood map for planning (Flood map for planning - ST 80698 26702 22/02/2018 Ref: 76852-WX), the location of flood defences are shown not to be within the vicinity of our site.

Please can you confirm if there are any flood defences within out site?



We are currently working with our client to obtain planning permission for a proposed residential development at the above site (Site layout attached).

As part of the process we need to produce a Flood Risk Assessment. The site is shown on the Government Flood Map for Planning as being partially within Flood Zone 2 and Flood Zone 3, therefore an FRA is required.

As such we would require any information the Environment Agency have regarding flood issues, including:

- Confirmation that the area is not specified as Flood Zone 3b or "functional floodplain".
- Existing flood levels adjacent to the site.
- Any historic flooding information adjacent to the site.
