a) General – all four licensing objectives (b, c, d and e) (please read guidance note 10)

This application is for a time limited, temporary Christmas market consisting of 30 wooden chalets, 2 are 4 x 3m which will be Santa's grotto and a hot food concession with no alcohol selling cheese toasties and tartiflette. The remaining 28 chalets are 3 x 2.3 m and will house artisan traders who are local, some will be occupied by local alcohol producers selling locally made alcohol as off sales only though they may provide tasters. One hut will be for the provision of mulled wine and mulled cider and non alcoholic options.

The market starts on 23^{rd} November and finishes on 22^{nd} of December and will be open daily between 10 - 7.

There is also an ice rink which is open at the same times

The market is staffed at all times by employee's of Dorset Artisan market and one hut has been designated as an information point and will be manned during opening hours. We will also provide a security guard to work alongside the Brewery Square Security, our SIA security guard will be on site from 9am until 8pm. The chalets are all lockable, some are on daily hire, some weekly and some for the entire duration of the market.

The hut selling mulled wine and cider and non alcoholic juice is designed for sales to the market customers, all traders with alcohol products will have a refusals register, a think 21 poster and will be asking for a recording ID for those thought to be under 18.

The entirety of the Christmas market is covered by the Brewery Square CCTV system.

We did consider have a certain number of chalets selling alcohol and numbering these on the attached plan but due to the nature of the bookings, some are weekly, some are daily and some are for the whole duration of the event but this does not work and would limit any future bookings made, there will only be one chalet selling alcohol for consumption on the premises the others with alcohol sales are off sales only and designed as Christmas gifts rather than immediate consumption.

b) The prevention of crime and disorder

This is a Christmas market and is operated in the same manner as the monthly Dorchester markets and occupy the same positions as 3 x 3m gazebos on market days, see attached plans. We do not anticipate crime and disorder but in any event we will have an SIA officer on during during opening hours and Dorset Artisan Market staff who have worked numerous events including Sherborne Pride, Pack Monday and The Sherborne and Dorchester Markets all staff have undertaken counter terrorism training in preparation for Martyns Law and have a thorough understanding of markets and large events. Our market manager was the Market Manager for Edinburgh Christmas Market in 2023.

c) Public safety

The market starts on Christmas Light switch on day and each chalet has festoon lighting so there will be additional lighting in place.

d) The prevention of public nuisance

As above but we have also taken into consideration crowds that may attend and we have booked a set of toilets (male, female, disabled and baby changing) for the event so that people are not using local businesses and we have purchased a number of additional bins. There will be regular litter picking and toilet checks throughout the day. Bin bags, cleaning equipment and additional toilet rolls will be kept in the information chalet

e) The protection of children from harm

Santa's grotto will be open all day during the market, Santa is going through a DBS check. With regards to sales of alcohol each hut selling alcohol will have an age related sales poster, refusals register, they will be checking ages against ID where any concerns arise and we have an SIA officer on site. The huts do not have any other age related sales, there will be no vapes, tobacco, knives, fireworks or any product with an age rating. All the traders that are trading with us for the Christmas Market have traded with us at other events and are local, artisan producers and not suppliers of mass manufactured products. We have a Lost / Found children and Vulnerable adults policy and a qualified first aider with the first aid kit being held in the information gazebo.

They do this in one of two ways: 1) by providing with this application copies or scanned copies of the documents listed below (which do not need to be certified), or 2) by providing their 'share code' to enable the licensing authority to carry out a check using the Home Office online right to work checking service (see below).

Documents which demonstrate entitlement to work in the UK

- An expired or current passport showing the holder, or a person named in the passport as the child of the holder, is a British citizen or a citizen of the UK and Colonies having the right of abode in the UK [please see note below about which sections of the passport to copy].
- An expired or current passport or national identity card showing the holder, or a person named in the passport as the child of the holder, is a national of a European Economic Area country or Switzerland.
- A Registration Certificate or document certifying permanent residence issued by the Home Office to a national of a European Economic Area country or Switzerland.

- A Permanent Residence Card issued by the Home Office to the family member of a national of a European Economic Area country or Switzerland.
- A **current** Biometric Immigration Document (Biometric Residence Permit) issued by the Home Office to the holder indicating that the person named is allowed to stay indefinitely in the UK, or has no time limit on their stay in the UK.
- A **current** passport endorsed to show that the holder is exempt from immigration control, is allowed to stay indefinitely in the UK, has the right of abode in the UK, or has no time limit on their stay in the UK.
- A current Immigration Status Document issued by the Home Office to the holder with an endorsement indicating that the named person is allowed to stay indefinitely in the UK or has no time limit on their stay in the UK, when produced in combination with an official document giving the person's permanent National Insurance number and their name issued by a Government agency or a previous employer.
- A birth or adoption certificate issued in the UK, when produced in combination with an official document giving the person's permanent National Insurance number and their name issued by a Government agency or a previous employer.
- A birth or adoption certificate issued in the Channel Islands, the Isle of Man or Ireland **when produced in combination with** an official document giving the person's permanent National Insurance number and their name issued by a Government agency or a previous employer.
- A certificate of registration or naturalisation as a British citizen, **when produced in combination with** an official document giving the person's permanent National Insurance number and their name issued by a Government agency or a previous employer.
- A **current** passport endorsed to show that the holder is allowed to stay in the UK and is currently allowed to work and is not subject to a condition preventing the holder from doing work relating to the carrying on of a licensable activity.
- A **current** Biometric Immigration Document (Biometric Residence Permit) issued by the Home Office to the holder which indicates that the named person can currently stay in the UK and is allowed to work relation to the carrying on of a licensable activity.
- A **current** Residence Card issued by the Home Office to a person who is not a national of a European Economic Area state or Switzerland but who is a family member of such a national or who has derivative rights or residence.
- A current Immigration Status Document containing a photograph issued by the Home Office to the holder with an endorsement indicating that the named person may stay in the UK, and is allowed to work and is not subject to a condition preventing the holder from doing work relating to the carrying on of a licensable activity when produced in combination with an official document giving the person's permanent National Insurance number and their name issued by a Government agency or a previous employer.

- A Certificate of Application, **less than 6 months old**, issued by the Home Office under regulation 18(3) or 20(2) of the Immigration (European Economic Area) Regulations 2016, to a person who is not a national of a European Economic Area state or Switzerland but who is a family member of such a national or who has derivative rights of residence.
- Reasonable evidence that the person has an outstanding application to vary their permission to be in the UK with the Home Office such as the Home Office acknowledgement letter or proof of postage evidence, or reasonable evidence that the person has an appeal or administrative review pending on an immigration decision, such as an appeal or administrative review reference number.
- Reasonable evidence that a person who is not a national of a European Economic Area state or Switzerland but who is a family member of such a national or who has derivative rights of residence in exercising treaty rights in the UK including:
 - evidence of the applicant's own identity such as a passport,
 - evidence of their relationship with the European Economic Area family member – e.g. a marriage certificate, civil partnership certificate or birth certificate, and
 - evidence that the European Economic Area national has a right of permanent residence in the UK or is one of the following if they have been in the UK for more than 3 months:
 - (i) working e.g. employment contract, wage slips, letter from the employer,
 - (ii) self-employed e.g. contracts, invoices, or audited accounts with a bank,
 - (iii) studying e.g. letter from the school, college or university and evidence of sufficient funds; or
 - (iv) self-sufficient e.g. bank statements.

Family members of European Economic Area nationals who are studying or financially independent must also provide evidence that the European Economic Area national and any family members hold comprehensive sickness insurance in the UK. This can include a private medical insurance policy, an EHIC card or an S1, S2 or S3 form.

Original documents must not be sent to licensing authorities. If the document copied is a passport, a copy of the following pages should be provided:

(i) any page containing the holder's personal details including nationality;

- (ii) any page containing the holder's photograph;
- (iii) any page containing the holder's signature;
- (iv) any page containing the date of expiry; and

(v) any page containing information indicating the holder has permission to enter or remain in

the UK and is permitted to work.

If the document is not a passport, a copy of the whole document should be provided.

Your right to work will be checked as part of your licensing application and this could involve us checking your immigration status with the Home Office. We may otherwise share information with the Home Office. Your licence application will not be determined until you have complied with this guidance.

Home Office online right to work checking service

As an alternative to providing a copy of the documents listed above, applicants may demonstrate their right to work by allowing the licensing authority to carry out a check with the Home Office online right to work checking service.

To demonstrate their right to work via the Home Office online right to work checking service, applicants should include in this application their 9-digit share code (provided to them upon accessing the service at https://www.gov.uk/prove-right-to-work) which, along with the applicant's date of birth (provided within this application), will allow the licensing authority to carry out the check.

In order to establish the applicant's right to work, the check will need to indicate that the applicant is allowed to work in the United Kingdom and is not subject to a condition preventing them from doing work relating to the carrying on of a licensable activity.

An online check will not be possible in all circumstances because not all applicants will have an immigration status that can be checked online. The Home Office online right to work checking service sets out what information and/or documentation applicants will need in order to access the service. Applicants who are unable to obtain a share code from the service should submit copy documents as set out above.
