### THE DORSET COUNCIL (OFF-STREET PARKING PLACES) (CONSOLIDATION) (AMENDMENT NO. 3) ORDER 2025

Dorset Council, having consulted with the chief officer of Dorset Police in exercise of the powers conferred by the Road Traffic Regulation Act 1984 as amended, the Local Government Act 1985 and the Traffic Management Act 2004 and in compliance with the Local Authorities Traffic Orders (Procedure) (England and Wales) Regulations 1996 and all other powers so enabling hereby makes the following order:

#### Part 1: Implementation and citation

- This Order is made and shall come into operation on 27<sup>th</sup> January 2025 and may be cited as " The Dorset Council (Off-Street Parking Places) (Consolidation) (Amendment No. 3) Order 2025".
- 2. Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended by any subsequent enactment.
