



## THE COUNTY OF DORSET (A35, A350, B3067 & LONGMEADOW LANE, UPTON) (30MPH SPEED LIMIT) (NO. \*) ORDER 202\*

Dorset Council in partnership with Bournemouth, Christchurch and Poole Council, as Traffic Authorities, in exercise of their powers conferred by the Road Traffic Regulation Act 1984 as amended, and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with paragraph 20 of the Schedule 9 of the Act 1984, hereby make the following Order: -

- 1 No person shall cause or permit any vehicle to be driven at a speed exceeding 30 miles per hour on the lengths of roads specified in Schedule 1 to this Order.
- 2 This Order may be cited as 'The County of Dorset (A35, A350, B3067 & Longmeadow Lane, Upton) (30mph Speed Limit) (No\*) Order 202\*' and shall come into operation on the \*\* day of \*\*\*\*\* 202\*.

## Schedule 1 30mph Speed Limit

Road	Description
A35 Upton Road (part)	From Longmeadow Lane at the Upton Gateway Roundabout in a south easterly direction for approximately 16 metres to the Unitary Authority boundary.
A35 Upton Road (part)	From the Unitary Authority boundary at Upton Gateway Roundabout, in an easterly direction for approximately 24 metres to the existing 30mph restriction.
A35 Upton Bypass east bound slip road (part)	From the Unitary Authority boundary at Upton Gateway Roundabout, in a south easterly direction for approximately 61 metres.
A35 Poole Road (part)	From the Unitary Authority boundary at Upton Gateway Roundabout, in a south westerly direction for approximately 163 metres to its junction with the B3067 Poole Road.
A35 Upton Bypass west bound slip road (part)	From its junction with the A35 Poole Road and the B3067, in a westerly direction for approximately 124 metres.
A350 Poole Road (part)	From its junction with the B3067, in an easterly direction for approximately 95 metres to the entrance of Upton House, Upton at the Unitary Authority boundary.
A350 Poole Road (part)	From the Unitary Authority boundary, in an easterly direction for approximately 19 metres.
B3067 Poole Road (part)	From its junction with the A35 Upton Bypass west bound slip road and A35 Poole Road, in a southerly direction for approximately 31 metres to its junction with the A350 Poole Road and continuing in a westerly direction for approximately 241 metres to the existing 30mph restriction.
Longmeadow Lane (part)	From the A35 Upton Bypass east bound slip road at the Upton Gateway Roundabout in a north easterly direction for approximately 61 metres to the existing 30mph restriction.
