This is the final version of the Purbeck Local Plan which will replace the existing Purbeck Local Plan Part 1. It has been through several rounds of consultation and a statutory examination process and found sound and legally compliant with planning regulations. No changes have been made since the last consultation and EqIA.

The Purbeck Local Plan has been shaped by consultation and engagement involving local people, businesses, community groups, external partners and relevant internal officers. It is based on evidence and the results of consultations undertaken in 2015, 2016 and 2018 prior to the Council submitting the plan for examination, additional evidence submitted during the examination and the results of consultations on modifications to policies in 2020-21, 2021-22 and 2023.

## 4. Please provide a brief overview of its aims and objectives:

The Plan sets out:

- the Council's vision and objectives for the area's development over the plan period;
- policies to ensure that development delivers sustainable homes, built to a high quality of design and maintains our high quality built and natural environment;
- the locations for housing growth and requirements for affordable housing;
- policies to build a strong, competitive economy and set out the future distribution for new employment land space and thus new jobs;
- policies to maintain and enhance the vibrancy and vitality of our town centres;
- policies to support a sustainable transport and road infrastructure network;
   and
- proposals for delivery including an Infrastructure Delivery Plan (IDP) to demonstrate the infrastructure requirements necessary to support the development proposed in this plan.

Rural isolation		Policy E1 Landscape: There is potential impact for would-be rural dwellers as development is restricted due to environmental constraints. Whilst this is unavoidable the policy does allow for some development and cumulatively the whole plan will allow for an element of choice in housing locations.
	Unclear impact	Policy E7 Conservation of protected sites and Policy E8 Dorset Heathlands: There is potential impact for would-be rural dwellers as development is restricted due to environmental constraints. Whilst this is unavoidable the policy does allow for some development and cumulatively the whole plan will allow for an element of choice in housing locations.
		H2 Housing land supply: The policy identifies the objectively assessed need for new homes in designated locations. Whilst this development is spread across the area it does focus, in the main, on current settlements. This may increase rural isolation, although, this will in part be mitigated by improving transport links (policy I2).

		The plan avoids exacerbating rural isolation by focussing new development in towns and larger villages where services are available.	
		Policy EE1 Employment land supply: The policy will support a variety of opportunities on employment land providing certain criteria can be met. The policy states that employment sites are located particularly in the towns and villages; this could have an impact on rural dwellers. However, employment sites in rural areas may not be viable and the proposed locations are dispersed.	
		Policy H13 Rural Workers homes in the countryside: The council acknowledges that new rural workers homes may be needed to support new rural businesses and to allow existing businesses to grow. The policy requires the applicant to demonstrate an essential functional need to be living close to their workplace.	
	Minor positive impact	Policy I7 Community facilities and services: The policy will benefit all members of the public by safeguarding existing community facilities and provision of new facilities for new development. There is a potential conflict for rural isolation as new facilities will be encouraged to locate within a defined settlement. Whilst this is difficult to mitigate other policies within the plan seek to improve transport links.

Single parents	Neutral Impact	The policies in the plan do not impact on single parents.	

## Please provide a summary of the impacts:

The Plan seeks to promote accessibility and connectivity to housing, employment, education and leisure facilities throughout the plan area. Specialist groups are supported through policy requirements, ensuring that an appropriate mix of housing and accommodation types is provided to meet the needs of all residents. This includes support for proposals for housing specifically designed to meet the identified needs of older people, specialist accommodation and self-build/custom build housing.

The Plan demonstrates the Council's ongoing commitment to equality, promoting cohesive communities in the plan area through area specific policy. Chapters 5 and 6 of the Plan and the spatial strategy highlight the support for diverse interconnected communities, identifying socio-economic objectives at the strategic and local level. This will maximise infrastructure delivery and employment opportunities in areas of lower economic status, contributing towards addressing pockets of deprivation. Taking this into consideration, it is appropriate to conclude that the Plan would have significant positive long term effects.
