# The County of Dorset (Fairfield and Rashley Road, Chickerell) (School Street) (Prohibition of Motor Vehicles) (No.2) Order 2024

Dorset Council in exercise of powers under the Road Traffic Regulation Act 1984 and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with paragraph 20 of the Schedule 9 of the Act 1984, hereby make the following Order: -

#### **CITATION**

This Order may be cited as 'The County of Dorset (Fairfield and Rashley Road, Chickerell) (School Street) (Prohibition of Motor Vehicles) (No.2) Order 2024' and shall come into operation on the 6<sup>th</sup> December 2024.

### INTERPRETATION

- 2 In this Order the following expressions shall have the respective meanings assigned to them:
  - "Chickerell Primary Academy Permit" means a permit issued at the discretion of Chickerell Primary Academy to allow access to and from the school site.
  - "Access Permit" means a permit issued at the discretion of the Council to allow access to lengths of roads that are otherwise subject to the restriction.
  - "Restricted hours" means the periods between 8.15am until 8.45am and 2.45pm until 3.15pm on every school day.
  - "the 1988 Act" means the Road Traffic Act 1988;
  - "Motor vehicle" has the same meaning as in the 1988 Act and includes any part of a vehicle.

## **PROHIBITION OF DRIVING**

3 Save as provided in Article 4 of this Order, no person shall cause or permit any motor vehicle to enter into or proceed on the length of roads during the restricted hours specified in Schedule 1 to this Order.

#### **EXEMPTIONS**

- 4 Nothing in this Order shall apply to a vehicle in the following circumstances:
  - (a) The vehicle is directed by or with the permission of a police officer or Civil Enforcement Officer in uniform.
  - (b) The vehicle is being used for emergency services purposes.
  - (c) Residents requiring access or egress.
  - (d) The vehicle is displaying an Chickerell Primary Academy Permit obtainable from Chickerell Primary Academy, on the vehicle's windscreen.

- (e) The vehicle is displaying an access permit obtainable from the Council, on the vehicle's windscreen.
- (f) The vehicle is being used in connection with the laying, erection, alteration, or repair of any main, pipe or apparatus for the supply of gas, water or electricity or of any telegraphic line as defined in the Telecommunications Act 1984 and cannot conveniently be used for such purposes from any other location.
- (g) The vehicle is being used in the service of a local authority or a water authority in pursuance of statutory powers or duties and cannot conveniently be used for such purposes from any other location.
- (h) The vehicle is being used in connection with the removal of any obstruction to traffic.

Fairfield, Chickerell	Entire Length	8.15am until 8.45am 2.45pm until 3.15pm on every school day.
Rashley Road, Chickerell	From its junction with Fairfield Road in a northernly direction for approximately 20 metres.	8.15am until 8.45am 2.45pm until 3.15pm on every school day.
